（五）领导小组办公室设在教学部（实验室管理中心），负责日常协调和会议组织等日常工作。

Notice on the Establishment of the Wenzhou-Kean University Laboratory Safety Leading Group

To all departments and colleges,

In order to thoroughly implement the guiding principles of the *Higher Education Laboratory Work Rules*, the *Higher Education Institution Laboratory Safety Standards*, the *Zhejiang Province Higher-Education Institution Laboratory Safety Management Measures* and other relevant documents, and to effectively enhance the University's laboratory safety management, improve the management system, clarify safety responsibilities, comprehensively prevent and mitigate laboratory safety risks, and ensure the safe and orderly conduct of teaching and research activities, it has been decided at the fourth University Cabinet Meeting of 2026 to establish the Wenzhou-Kean University Laboratory Safety Leading Group (hereinafter referred to as the "Leading Group").

The relevant matters are hereby notified as follows:

I. Composition of the Leading Group

II. Main Responsibilities of the Leading Group

2.1 To fully implement national, provincial, and municipal laws, regulations, and policy documents concerning laboratory safety in higher education institutions;

2.2 To formulate the University's laboratory safety guidelines and determine policies and principles for laboratory safety management;

2.3 To plan and coordinate the University's laboratory safety work, and deliberate and implement major initiatives and measures;

2.4 To guide and supervise laboratories in fulfilling safety management responsibilities and conducting hazard identification and rectification, so as to ensure the safe and orderly conduct of teaching and research activities;

2.5 The Leading Group Office is established within the Office of Academic Affairs (Laboratory Management Center) and is responsible for routine coordination, meeting organization, and other day-to-day operations.
